In an effort to continually improve the community, DoubleGate formed an HOA some years ago. The HOA is managed by neighborhood volunteers: block and zone captains, assorted committee chairs, and an elected board. HOA dues and volunteers support:

- The maintenance of entrances to our subdivision, including landscaping, lighting, and irrigation
- A neighborhood Directory, updated periodically and published yearly

III. Applicant understands that he shall have no beneficial interest in the properties of the Club but only the privilege of using and enjoying the Club's facilities.

IV. Initiation Bond and Annual Dues will be assessed on the following basis:

A. Initiation Bond for membership in Swim and Tennis is \$1500. A \$300 discount is available to new homeowners who join within 30 days of closing on their residence. Please call the Membership chairman, Laura Mara, (770) 840-0592, for more information.

B. The Club's Membership Year will be from June 1 of the current calendar year through May 31 of the following year. Annual Dues, currently \$495, will be billed on or about April 15th. Any member who does not pay on time will be assessed a 10% late fee. Annual Dues for members will be due and payable 30 days from the billing date. Residents who join the Club after July 1 will have Annual Dues assessed on a prorated basis.

DoubleGate Swim and Tennis Club, Inc. Resident Membership Application (cont'd)

V. Refunds of Initiation Bonds will be provided in accordance with the following policy:

A. Homeowners/ members who join(ed) the Club AFTER JUNE 1, 1991 and sell their home, which precludes their continued membership in the Club, are entitled to a refund of 2/3 of their bond the first year. Each year thereafter, the refund available will be 2/3 of the previous year's availability, until the sixth (6th) year, when no refund will be available.

B. One half of Annual Dues are refunded if the member moves within the first six months (June 1 – Nov. 30). They are not pro-rated – it's one half or nothing. If members are past the 5 year limit for Bond refunds, they may still receive a refund of the Annual Dues.

C. The Club has the right to hold this refund until your membership has been replaced by a new member and the Board has reviewed the financial condition of the Club and its ability to make this payment. Every effort will be made to return these monies as soon as possible.

D. Initiation Bonds are not transferable.

VI. Payment of the Initiation Bond and Annual Dues should be submitted in separate checks payable to *DoubleGate Swim and Tennis Club, Inc.* Checks must be made in full (no partial payments). These checks, along with the completed RESIDENT MEMBERSHIP APPLICATION form should be mailed to:
